Guiding principles: The minimum amount of any distribution from a Fund is \$250 at one time to a single charity. Distributions can occur as often as once monthly and must occur at least once annually. The minimum annual distribution shall be 5% of the total value of the Fund. The minimum balance for a Fund is \$5,000. The EFCA interprets its exempt purpose to allow distributions to support a limited number of legitimate charitable, scientific, literary, and educational causes which are not overtly Christian in nature but are consistent with a Christian profession of faith. Such allowances shall not be stretched to embrace, nor will distributions be made to support, causes which the EFCA deems to be antietical to the mainstream of historic Christian faith. Please refer to your DAF agreement for additional details.
